the President or if he is otherwise satisfied, may be in writing that he is a member of the Arya Samaj.

3. The Society shall comprise all persons who have donated Rs 250/- or more in one lump sum or have been members of the Society for a period of a permanent nature and are members of the Arya Samaj.

4. Every member of the Arya Pradeshik Pratishthi Sabha shall be subject to the approval of the President, DAV College Managing Committee, New Delhi, provided that the Society may waive the condition of affiliation with the Arya Samaj in case of any notified Arya Samaj of Arya Pradeshik.

5. Every member of the Dayanand Anglo-Vedic College Trust & Management Society shall pay a least Rs. 12/- as yearly subscription or Rs. 100/- for life.

6. No member of the Society shall be entitled to vote at a meeting of the Society unless he has paid monthly subscription at the rate specified in Regulation 4 for the twelve months preceding the date of the meeting concerned.

7. The membership, whatever is left, and his name shown in the register of members prepared for the year under Regulation 4.

8. Subject to the control of the Dayanand Anglo-Vedic College Trust & Management Society and to such Regulations as have been passed by or may from time to time be passed by the said Society, the affairs of the Society shall be conducted in objects carried out and the institutions under its control managed by a Managing Committee, which shall be composed of members returned from the Arya Samaj in accordance with the provisions of Regulation 7 (seven) and
