Annexure - I

the President or if he is otherwise satisfied, may accept in writing that he is a member of the Arya Samaj.

3. The Society shall comprise all the persons who have donated Rs. 250/- or more in one lump sum of a permanent nature and are members of an Arya Samaj affiliated to the Arya Pradeshik Pratinidhi Sabha, but subject to the approval of the President, D.A.V. College Managing Committee, New Delhi, provided that the Society may waive the condition of affiliation with the Arya Samaj in case of any specified Arya Samaj of Arya Pradeshik Pratinidhi Sabha.

4. Every member of the Dayanand Anglo-Vedic College Trust & Management Society shall pay at least Rs. 12/- as yearly subscription or Rs. 100/- for life.

5. No member of the Society shall be entitled to vote at a meeting of the Society unless he has paid monthly subscription at the rate specified in Regulation 4 for the twelve months preceding the date of the meeting or since the date of his membership, whichever is less, and his name shown in the register of members prepared for the year under Regulation 6.

6. Subject to the control of the Dayanand Anglo-Vedic College Trust & Management Society and to such Regulations as have been passed by or may from time to time be passed by the said Society, the affairs of Society shall be conducted in accordance with its objects, carried out and the institutions under its control managed by a Managing Committee which shall be composed of the following members:

- (a) Members returned from the Arya Samaj in accordance with the provisions of Regulation 7 (seven) and 8 (eight).

(b) Members elected, if any, under Regulation 7 (seven) (sixteen).

(c) Principals of Colleges controlled and managed by the D.A.V. College Managing Committee and affiliated to any University in India.

(d) One representative of Life Members of the Society and one representative of the Society.

(e) Members appointed, if any, under Regulation 7 (eighteen).

Subject to Regulation 7 (11) the right to return representatives to the Managing Committee shall vest in the Arya Samaj as under: Vide D.A.V. College Trust & Management Society Resolution No. 6 D.V. 30-5-87.

1. Arya Pradeshik Pratinidhi Sabha (Five) Representatives will be nominated from the Arya Samaj in Delhi affiliated to the Pradeshik Pratinidhi Sabha except from those which have a separate representation and ten representatives will be nominated from amongst places where DAV educational institutions exist but there is no representation).

- 2. Ambala (City and Cantt.) (Representatives will be elected at a combined meeting of City and Cantt. Arya Samaj held under the auspices of City Arya Samaj)
- 3. Amritsar (Lohgarh)
